2020 Punkin Days CHILI Cook-off Rules

1. All teams must submit an entry form and pay the \$25 entry fee to compete.
2. Entry forms may be obtained by emailing manager@floydadachamber.com
3. Entry forms must be received by start time of competition.
4. Each team will provide their own equipment and supplies including a grill/cooker and cooking equipment.
5. Each team will bring their own products, including raw, unseasoned meat and seasonings.
6. Each team will receive a designated space to cook under a permanent awning.
7. All marinating, seasoning, and cooking of the product shall be done within the confines of the team's assigned cooking space. No seasoning, marinating or cooking of any kind may begin before 8:30 am.
8. Contestants must adhere to all electrical, fire, health and other codes.
9. All contestants are expected to respect the rights of other teams. Profane language or infringement on another team's area will not be permitted.
10. All cook off areas must be cleaned and vacated by 7 pm on Saturday.

1. Tents, awnings, tables will NOT be provided. Please bring everything you need.

7:00 am – set up begins.

8:00 am – team check in – all meat must be raw and uncooked at check-in and presented for inspection **in original packing from the store.**

8:30 am – cooking can begin

2:00 pm – judging turn-in time

3:30 pm – Winners announced under pavilion

Judging

1. Blind judging containers will be handed out at check-in.
2. All samples must be delivered to the judging location at 2:00 pm.
3. Entries will be judged by a team of three (3) judges.
4. The decision of the judges is final.
5. You are welcome and encouraged to hand out samples; however, you are not allowed to accept any kind of payment for them.
